- LMJ FILM will take utmost care to produce a video of excellent quality. However, we will not be held responsible for circumstances beyond our control, including but not limited to power failure, weather, equipment malfunction, and defective tape stock or client misuse of equipment. If filming is prevented due to such occurrences, all money paid will be refunded, minus your initial deposit.
- LMJ FILM reserves the right to terminate contract for any reason at any time. Should LMJ FILM terminate the contract, all monies paid will be refunded.
- All audio and video footage is the copyrighted property of LMJ FILM. LMJ FILM reserves the right to use any and/or all footage for promotional purposes. The video is strictly produced for the client's private, home use only. Any duplication or broadcast (including internet use) without written consent of LMJ FIM is strictly prohibited. Clients assume all liability for any form of copyright infringement.

- It is the client’s sole responsibility to inform LMJ FILM of any specific needs or changes in events.
- In addition to mileage, a travel charge of \$25.00 will be assessed when wedding related events occur further than 20 miles from each other.
